# Section 2: Instruction to Bidders

### **2.1 Introduction to Concern**

Concern Worldwide (CWW) is a non-governmental, international, humanitarian agency that was founded in 1968. The organisation is devoted to the relief, assistance and advancement of people in greatest need in less developed areas of the world. Concern Worldwide's vision is a world where people no longer live in extreme poverty, fear or oppression; a world where every person has access to a decent standard of living and the opportunities and choices basic to enjoying a long, healthy and creative life; a world where every person is treated with dignity and respect; a world where there is peace and solidarity among people. The organisation's headquarters are in Dublin, Ireland.

### 2.2 Concern Worldwide Somalia

Concern Worldwide is a non-governmental, international, humanitarian organization dedicated to the reduction of suffering and working towards the ultimate elimination of extreme poverty in the world's poorest countries. Concern Worldwide has been operational in Somalia with a continual presence since 1992. The organization is currently implementing several multi-sectoral emergency, resilience and durable solutions programmes encompassing food and livelihood security, health and nutrition, WASH, and education across Banadir, Bay, Lower Shebelle, and Gedo regions. Concern implements programmes both directly and indirectly through local partners and contractors

## 2.3 Background of the Tender

The School Feeding Programme involves an integrated approach to increase enrolment, retention and learning for learners targeted by the ECW MYRP. As recognised by the Education Cannot Wait, 'School Health and Nutrition programmes support learners in getting into school, staying in school, and improving learning. Furthermore, Education returns on school feeding are in fact highest amongst girls. It is acknowledged by ECW that stand-alone school feeding (i.e. direct distribution of basic food rations at the school level) may have a positive effect on school enrolment. However, the MYRP is designed to have positive impact beyond enrolment alone and extending to retention and learning. As marginalised children, particularly disadvantaged girls and IDPs in targeted locations of Somalia are most likely to suffer from ill health and malnutrition, the impact is expected to be highest amongst this target group in terms of their attendance and ability to learn once in school.



The interventions are expected to contribute to an increased percentage of girls and boys enrolled in primary education in 10 formal Public schools/EiE locations in Southwest and an increased percentage of emergency-affected youth enrolled in ABE programs equivalent to primary education.

Concern Worldwide intends to undertake Provision of school feeding programme to the children of five target schools in Baidoa, Under Education Cannot Wait (ECW) Multi-Year Resilience Programme (MYRP). Concern is looking for a qualified contractor(s) to provide wet food to 5 target schools in Baidoa in a timely manner.

# 2.5 Submission of Bids

Tender Dossier will only be accepted in the format requested. Any incomplete responses or responses not in the format of the template provided shall be treated as null and void.

The deadline for receipt of bids is on **20<sup>th</sup> November 2021 by 5:00pm East Africa time.** Any bid submitted after the deadline, will not be accepted. Bids will be opened on **21<sup>st</sup> November 2021**.

## 2.6 Supporting Documentation to be submitted together with Bid Applications

Copies of the following supporting documentation **must** be submitted together with each Bid Application, failure to which the bid will be disqualified:

- Original bank statement signed and stamped by the relevant bank authority including transactions for the past 6 months.

- Duly completed Financial Offer
- Tender Declaration Form completed, signed and stamped

# Section 3: Evaluation of Tenders

All valid bids received will be evaluated by the Tender Evaluation Committee (TEC) who will assess the bids based on administrative compliance, technical and financial evaluation grids set in line with the information provided in the bid application. The TEC has the right to visit the bidder's physical office premises during the tender evaluation process, if deemed necessary to ascertain the bidders' capacity to undertake the school feeding Programme activities (provision of food).

## **3.1 Administrative Compliance Check**

All bidders must meet with administrative compliance check in order to progress to the next stage of the tender evaluation process (i.e. technical evaluation). The administrative compliance check includes the following:

- 1) Bid applications must be received within the deadline
- 2) Submission of a comprehensive company profile
- 3) Valid business registration/License certificate by SWS
- 4) Tax compliance certificate by SWS
- 5) Original bank statement including the transactions for the past 6 months, signed and stamped by the relevant bank authority.
- 6) Duly completed Financial Offer,



7) Tender Declaration Form completed, signed and stamped

**NOTE:** These checks are scored as *Pass or Fail* and the bidder who does not meet them all will not proceed to the technical evaluation stage.

## 3.2 Technical Evaluation Criteria (weighted at 70%)


Technical Competence (these include previous relevant experience, sample quality, financial capacity, delivery time and other competence). To be technically acceptable, the proposal shall meet or exceed the stipulated requirement and specifications in the Bid document. The Technical Evaluation Criteria is weighted at **70%**. Tenders who obtain a score of **50% and above** will qualify to proceed to the next round of the evaluation process (financial evaluation). Considerations in the technical evaluation process includes.

- 1. Company profile **15 points** 
  - 10 points for company information such as name, physical address, office telephone number and Email address, Contact details name and phone number and Company business License/Registration Number.
  - 5 points for number of years in operation
- 2. Financial viability 7 points
  - 4 points for bank transaction details provided
  - 3 points for length of the bank account operation
- 3. Payment Terms **15 points** 
  - 5 points for detailed proposed payment schedules
  - 5 points for Preferred payment method (cheque/electronic)
  - 5 points for company's credit period upon submission of an invoice to Concern?
- 4. Delivery terms and price validity **15 points** 
  - 8 points for provision of reasonable distribution plan (school feeding schedule)
  - 7 points for quoted price validity
- 5. Relevant Experience for supply of Feeding Programme **18 points** 
  - 6 points for each of the previous 3 contracts/LPOs of school feedings programme undertaken by the bidder in the past 3 years.



## 3.3 Financial Evaluation (weighted at 30%)

The financial evaluation will be weighted at **30%**. The financial evaluation criteria will use the formula below to arrive the bidder's financial score.



# 3. Bids Validity Period

All bids must be valid for **60 days** after the deadline for submission of bids indicated in the tender dossier.

# 3.5 Language of the bid

All bids shall be submitted in English

# 3.6 Currency

Bids shall be submitted in US dollar currency.

# 3.7 Confidentiality and data protection

Information relating to the examination, clarification, evaluation and comparison of bids, and recommendations for the award of a contract shall not be disclosed to bidders or any other persons not officially concerned with such process until the award to the successful bidder has been announced.

Concern guarantees that all procurement activities are fully and transparently documented for internal or donor audit purposes. Concern guarantees confidentiality of the procurement process.



## **3.8 Tender Committee Decision**

The recommendations of the tender committee shall not be limited to the overall score (Financial and Technical scores combined), however the outcome shall consider other factors including value for money. If there is significant monetary value difference between the bidder scoring the highest score and the second or the third bidder with a lower financial bid, then value for money shall take precedence and the one who quoted the lowest ( among the three finalists) shall be considered.

# **3.9 Food Provision Requirements**

Concern has constructed school kitchens and storage facilities for the 5 target schools of the feeding programmes in Baidoa for successful implementation of the programme. The Education programme has already provided the necessary materials needed for school feeding including: cooking pots, plates, cups, spoons etc. The successful bidder is expected to match with specifications of the integrated school-feeding programme in relation to particular schools as specified in the attached school feeding Bill of Quantity (BOQ):

- The potential vendors to supply assorted wet food to the learners at ECW/MYRP supported schools in Baidoa as specified in the attached BOQ for a **period of 7 months.**
- The food provisions shall commence within 7 days of signing contract with Concern failure to which the contract will be cancelled.
- The supply of food rations consisting of sweetened porridge (served at 10:00Am) and polished rice, assorted seeds (served for lunch at 12:45Pm).
- The successful contractor shall engage Community Education Committees (CEC) at school level to enable them own and lead the school feeding programme, including managing the process of storing and preparing food, establishing and maintaining the school kitchen and distributing the wet food to the school children during break times.
- The contractor shall hire **15 cooks for the school feeding programme** who will be selected from the school by the respective CECs to ensure smooth implementation of the school feeding programme.
- The contractor shall train the cooks in the proper management of school feeding programme, food supplementation approaches, including cleanliness of school kitchen and the feeding environment.
- The bidder confirms goods offered meet specifications provided in the tender dossier (BoQ) .

# 3.10 Clarifications/Amendments to the bid document

At any time prior to the deadline for submission of bids, Concern may for any reason, whether at its own initiative or in response to a clarification requested by a prospective bidder, modify the bidding document by issuing an addendum. Any addendum thus issued shall be part of the bidding documents.

To assist in the examination, evaluation, and comparison of bids, Concern may at its discretion, ask any bidder for clarification of its bid, including breakdowns of unit rates. The request for clarification and response shall be in writing or by email but no change in the price or substance of the bid shall be sought, offered, or permitted except as required to confirm the correction of arithmetic errors discovered by the Tender Evaluation Committee.

## 3.11 Cancellation of the tender process

The tender evaluation committee has the right to cancel the tender process at any stage without having to explain the situation. Reasons for doing so might include; not receiving the minimum number of bids (3) required according to Concern policy, a drastic change in specification of the works, costs exceeding budgetary limits or the project being cancelled among others.
