2.5 Language of Offers

All correspondence and documents related to these Bids should be submitted in English.

2.6 Period of Validity of Offers

All bids must be valid for a minimum of Ninety (90) days from the tender submission date. Valid for a shorter period will not be accepted.

2.7 Currency

All bids should be submitted in US dollars. Any other currency will not be accepted.

2.8 Incoterms

The incoterm to be applied for the delivery of these items is Free Carrier (FCA) Mogadishu seaport.

2.9 Type of Contract and Lots

Supply contract with fixed quantities and time. This tender is issued in two different lots as per the below:

2.10 Opening of tenders

The opening of the submitted tender dossier will take place on Monday 6th October 2025 at 10:30 Hrs. in Concern Mogadishu Office. The tender opening session will be based on the total number of tenders received in the Websites. Each tender will be given a sequential number by the tender committee based on the date in which it will receive for the purposes of identification.

2.17 Specification Requirements for (RUTF, F-75 and F-100) Bidders

Tenderers for Lot#1 and Lot#2 are required to provide the following information or documents failure to which may lead to disqualification of their bid application:

- b. Certificate of conformity
- c. Certificate of origin
- d. Realistic lead time
- e. Sample picture of the product
- f. More other requirement from the supplier.
- g. Audited Account Statement for the last 3 years.

Section 3: Evaluation of the Tender & Content of tenders

All Valid bids received will be evaluated by Concern Tender Evaluation Committee and will assess the bids based on administrative compliance, Technical and financial evaluation grids set in line with the information provided in the bid application. Concern reserves the right to request proof of bidders' work experience and subsequently visit the premises if this is deemed necessary to complete the evaluation process.

3.1 Administrative Compliance Check – bid applications received will be subjected to a number of compliance checks in order to progress to the next stage of the evaluation process (i.e. technical evaluation).

These Checks are scored as Pass or Fail and only bidders that pass the administrative compliance checks will be considered to proceed to the next stage of the evaluation process (i.e. technical evaluation). The administrative compliance check includes the following:

3.2 Technical Competence – This is based on previous relevant experience, conformity with required specifications of supplies, financial capacity and lead time. To be technically acceptable, the proposal shall meet or exceed the stipulated requirements of the bid. The technical Evaluation Criteria is weighted at **70%**. Tenderers who obtain a score of **50%** and above will qualify to proceed to the next round of the evaluation process (financial evaluation). The following will be assessed on the technical competence:

Lot #2 Therapeutic formula milk

 Therapeutic formula milk F-75 for the initial phase of dietary management for children with medical complications. ((I.e. Unit size in grams, Carton Configuration and calories) - 4 points

- Therapeutic Formula Milk F-100 for the rehabilitation phase during the diary management of children with SAM packed ((I.e. Unit size in grams, Carton Configuration and calories) - 4 points
- Provision of sample picture for RUTF and F-75 & F-100 Therapeutic Milk (cartons, RUTF sachets and F-100/F-75 Therapeutic milk Contain types)—3 points

3.2.4 Relevant Experience for the supply of RUTF, F-100 and F-75 - 20 points

- Provision of minimum 4 contracts/LPOs for similar RUTF and F-75 & F-100 Therapeutic Milk accomplished by the bidder in the last 3 years in Somalia – each at 5 points
- **3.4 Financial evaluation** Tender Committee's consideration is based on the bidder with best quality supplies, least **delivery** time, availability of ex stock and most reasonable price and will carry a total score of **30% marks**. Duly completed Financial Offer, Acceptance of Payment Terms etc.

The financial score will be calculated using the formula below.

NB: Concern does not consider the financial offer to be the most important factor. The bidder awarded will be the bidder who achieves the highest aggregate score, combining both the financial and technical evaluations.
